THE EUROPEAN UNION IS INVESTIGATING OUR CRIMINAL COMPLAINT AGAINST THE SPANISH GOVERNMENT

The alliance Denunciantes del Autoritarismo Judicial has forwarded to the Spanish Supreme Court the registration of the complaint against the Sanchez governments (2018-2022).

On November 11, 2022, the Alliance denounced the Sanchez governments (2018-2022) for harming the Spanish people and the financial interests of the European Union and all its member countries.

This complaint was sent to the Spanish Supreme Court and to the European Commission, in the same e-mail, with a visible copy to Members of several Economic Commissions of the Congress.

In the email to the Spanish Supreme Court dated November 28, 2022, it is stated: "Without having received any notification from the Supreme Court, today (28.11.2022) we forward the email dated 25.11.2022, by which we are notified that our complaint has been registered for processing as Ares(2022)8174536, in the Unit F.3 - Economies of the Member States I (Croatia, Spain) of the Directorate General for Economic and Financial Affairs of the European Commission", requesting to join this letter to the procedure where the complaint is being processed.

We do not know whether any of the governments of the members of the European Union have appeared before the Supreme Court as injured parties. The Alliance informed several governments and, in addition, the complaint requests the Supreme Court to offer them the possibility of appearing.

This is the first time that an economic unit of the European Commission has processed a complaint against a State, demonstrating the exceptional situation that Spain and the European Union are going through, as well as our success.

Given the delicate situation of the Spanish economy, the absolute disregard for the legality of the Government, accredited in this complaint, the risk of the disappearance of the Euro and the disintegration of the European Union, as well as the fact that Spain

will preside the Council of the European Union as of July 1, 2023, the Supreme Court or the European Commission must force early General Elections to prevent Sanchez from electing this European President.

With this brief, the Supreme Court will be under pressure to comply with the strictest legality, not only because, in an unprecedented way, the damage to the "financial interests of the EU" will be judged, but also because several European institutions and other members of the European Union will be watching the procedural developments.

We also put pressure on the Spanish prosecutors of the European Public Prosecutor's Office, who have the exclusive institutional competence to investigate the facts, knowing that the European Commission and the European Parliament are fully aware of the complaint. Especially pressured will be María Concepción Sabadell Carnicero, Delegate Prosecutor in Spain of the European Public Prosecutor's Office, who has been denounced by the Alliance for covering up three complaints of 2021, against public officials.

Since 2021, the European Commission has had other complaints from the Alliance unprocessed.

The whistleblowers are particularly concerned about the low awareness of Spaniards that the only thing that can protect them from a totalitarian, corrupt and decadent regime is strict compliance with the laws by public authorities, especially parliamentarians, the government and judges.
