CRIMINAL COMPLAINT AGAINST THE GOVERNMENT (2018-2022) FOR HARMING THE SPANISH ECONOMY AND EUROPEAN FINANCIAL INTERESTS.

The Denunciantes del Autoritarismo Judicial alliance (Denouncing Judicial Authoritarianism) has denounced the governments of Pedro Sánchez, for some of its criminal actions from 2018 to the present.

It is an unprecedented complaint due to several aspects that may revolutionize the functioning of the European Union, the relations between European countries, the fight against corruption and the Spanish jurisprudence that has historically facilitated the high Spanish corruption (8% of GDP, Eurostat 2018).

It is denounced that the Councils of Ministers (governments) of President Pedro Sánchez, have acted as a criminal gang to commit a continuous crime of prevarication, coercion, embezzlement, false documentation and against the independence of Spain, as well as intergenerational and electoral crimes.

The crimes have been instruments that have managed to illegally increase public spending and public debt in 2019, breaching the electoral commitment and with the EU, European leadership in youth unemployment, the legal coup of 2020 (State of Alarm declared illegal by the Constitutional Court) to justify the record of public spending and achieve the biggest economic fall in the world in 2020, the worst management of EU funds, the worst recovery in 2021 and 2022, the non-compliance with the limitation of public spending and debt every year, repeatedly falsifying official documentation to avoid legal controls on public spending and to falsify unemployment data and other things.

In addition to the damage to Spanish interests, it is claimed that these governments have harmed the financial interests of the European Union, both by the fall in the value of the euro and by the financial bailout in the form of loans and "gifts".

The financial interests of the EU is a new legal asset, which means that Spanish jurisprudence cannot be applied to the reported offenses and that the investigation of the facts is the exclusive competence of the European Public Prosecutor's Office.

The Supreme Court, where the complaint is filed, will have to appoint a judge to act as a judge of guarantees, ensuring that the European Public Prosecutor's Office investigates in accordance with the law. The Law allows the complainant Alliance to require the European judge to review compliance with constitutional and procedural guarantees.

On October 14, 2022, the Alliance denounced Spain to the European Commission, because the transposition of the European Public Prosecutor's Office Regulation with Organic Law 9/2021, violated the Treaty on the Functioning of the European Union (TFEU), by limiting the persons and organizations that can exercise the popular accusation. In the complaint, the private plaintiff contests this law, requesting that the matter be referred to the Court of Justice of the European Union (CJEU) to be declared illegal.

Finally, the Supreme Court is asked to offer the governments of the EU member countries to join the case as injured parties, based on the indications in a document from the European Commission.

The complaint has been sent to several members of various European Parliament Committees, as well as to several European Union governments, inviting them to join the case; several foreign newspapers and the Group of States against Corruption (GRECO) have also been informed, so that they are aware of the seriousness of the deterioration of the Spanish rule of law, political corruption and the economic situation, as well as the present and future consequences for the European Union and the Euro.

With this complaint, the causes of the current cultural, political, institutional, social and economic crisis will be revealed.
